

Expedited pathway for registration in the provisional vocational scope of practice – approved postgraduate medical qualifications

A. Anaesthesia

Ireland

- Fellowship of the College of Anaesthetists of Ireland; or
- Fellowship of the Faculty of Anaesthetists, Royal College of Surgeons in Ireland

AND

- Certificate of Satisfactory Completion of Specialist Training (CSCST)

United Kingdom

- Fellowship of the Royal College of Anaesthetists

AND

- Certificate of Completion of Training (CCT) issued by either the General Medical Council or the Postgraduate Medical Education and Training Board; or
- Certificate of Completion of Specialist Training (CCST) issued by the Specialist Training Authority of the Medical Royal Colleges

B. Dermatology

Ireland

- Membership of the Royal College of Physicians of Ireland; or
- Fellowship of the Royal College of Physicians of Ireland

AND

- Certificate of Satisfactory Completion of Specialist Training (CSCST)

United Kingdom

- Fellowship of the Royal College of Physicians of Edinburgh; or
- Fellowship of the Royal College of Physicians and Surgeons of Glasgow; or
- Fellowship of the Royal College of Physicians of London; or
- Membership of the Royal College of Physicians of Edinburgh; or

C. Emergency medicine

United Kingdom

- Certificate of Completion of Specialist Training (CCST) issued by the Specialist Training Authority of the Medical Royal Colleges

D. General practice

Australia

- Fellowship of the Royal Australian College of General Practitioners

Ireland

- Membership of the Irish College of General Practitioners

AND

Certificate of Satisfactory Completion of Specialist Training (CSCST)

United Kingdom

- Fellowship of the Royal College of General Practitioners; or
- Membership of the Royal College of General Practitioners

AND

- Certificate of Completion of Training (CCT) issued by either the General Medical Council or the Postgraduate Medical Education and Training Board

E. Internal medicine¹

Ireland

- Membership of the Royal College of Physicians of Ireland; or
- Fellowship of the Royal College of Physicians of Ireland

AND

- Certificate of Satisfactory Completion of Specialist Training (CSCST)

United Kingdom

- Fellowship of the Royal College of Physicians of London; or
- Fellowship of the Royal College of Physicians of Edinburgh; or
- Fellowship of the Royal College of Physicians and Surgeons of Glasgow; or
- Membership of the Royal College of Physicians of London; or
- Membership of the Royal College of Physicians of Edinburgh; or
- Membership of the Royal College of Physicians and Surgeons of Glasgow

AND

F. Pathology (Anatomical)

United Kingdom

- Fellowship of the Royal College of Pathologists

AND

- Certificate of Completion of Training (CCT) in Histopathology issued by the General Medical Council

G. Psychiatry

Ireland

- Membership of the Royal College of Psychiatrists

AND

- Certificate of Satisfactory Completion of Specialist Training (CSCST)

United Kingdom

- Fellowship of the Royal College of Psychiatrists; or
- Membership of the Royal College of Psychiatrists

AND

- Certificate of Completion of Training (CCT) issued by either the General Medical Council or the Postgraduate Medical Education and Training Board; or
- Certificate of Completion of Specialist Training (CCST) issued by the Specialist Training Authority of the Medical Royal Colleges
