

## Te Whatu Ora – Nelson Marlborough – Progress on required actions

Nelson Marlborough DHB underwent an accreditation assessment as a provider of prevocational medical training on 6 and 7 August 2019.

The overall outcome of the assessment for Nelson Marlborough DHB's accreditation was '**substantially met**'.

On 1 July 2022, Te Whatu Ora | Health New Zealand replaced Aotearoa New Zealand's 20 DHBs. The prevocational training programme run by Nelson Marlborough DHB is now run by Te Whatu Ora – Nelson Marlborough.

Te Whatu Ora - Nelson Marlborough is currently accredited for prevocational medical training until 30 August 2025, subject to satisfactorily addressing the required actions listed below.

11	Nelson Marlborough must ensure that interns' workload in the surgical rotation is consistent with high quality training and safe patient care.	<p><b>Implementing the education and training framework – welfare and support (6.2.1)</b></p> <p>The duties, rostering, working hours and supervision of interns are consistent with the delivery of high-quality training and safe patient care.</p>	Addressed (Oct 2020)
